1. Information and data collected by THOMSON App

To this end, THOMSON App will automatically collect and use certain necessary information and data from your mobile device, such as mobile device information (brand, model, etc.), printer information (AP name, AP password, connected Wi-Fi, IP address, printer status, etc.), print job information (number of copies, paper size, print quality, etc.), scan job information (scan source, color, resolution, size, scanned image data, etc.), fax job information (fax quality, size, address book, fax number, etc.), and recently previewed web page information and recently used document information, etc.

2. How the information and data collected by THOMSON App are stored

Please note that the information and data collected by the App is stored locally on your mobile device only and will not be stored remotely or provided to us or any third party through Web services.

3. How the information and data collected by THOMSON App are deleted

You can delete the information and data collected by the App by:

- Going to "Settings" -> "Applications" menu on your mobile device, and touching "Clear Data" under the "Storage" option.
- Uninstalling the App, which will delete all the data collected, except the photos, scanned files, and imported address list collected and saved during printing, scanning, and faxing which need to be deleted manually under the "THOMSON" folder on the memory card of your mobile device.

4. Protection of your information

In order to protect your personal information from unauthorized access, misuse, disclosure or alteration, THOMSON takes reasonable and appropriate encryption procedures to ensure the security of the information collected and processed by the App. However, please note that, although we have taken reasonable steps to protect your information, no website, webcast, computer system, or wireless connection is completely secure.

5. Children policy

THOMSON does not intentionally collect information from children under the age of 13 (or the minimum age specified in the relevant jurisdiction), and our App is not intended for children under the age of 13 (or the minimum age specified in the relevant jurisdiction).
